



#### **How many Gopher Tortoises lived here?**



#### Nature's Complete & Perfect Ecosystem



- Gopher Tortoises are ancient reptiles.
- Their burrows average approximately 15-25 ft. long and up to 6 ft. deep.
- More than 350 animals depend on these burrows for refuge, including:
  - Gopher frogs
  - Burrowing owls
  - Florida pine snakes
  - Florida mice
  - Eastern indigo snake

## Florida State Law Protects Gopher Tortoises

Gopher Tortoises are a THREATENED species and are protected under State Law, Chapter 68A-27.003 of the Florida Administrative Code (FAC).



#### Rule 68A-27.003 (FAC)

The Gopher Tortoise is hereby declared to be threatened, and shall be afforded the protective provisions specified in this paragraph:

"The gopher tortoise (Gopherus polyphemus) is hereby declared to be threatened, and shall be afforded the protective provisions specified in this paragraph. No person shall take, attempt to take, pursue, hunt, harass, capture, possess, sell or transport any gopher tortoise or parts thereof or their eggs, or molest, damage, or destroy gopher tortoise burrows, except as authorized by Commission permit or when complying with Commission approved guidelines for specific actions which may impact gopher tortoises and their burrows. A gopher tortoise burrow is a tunnel with a cross-section that closely approximates the shape of a gopher tortoise. Permits will be issued based upon whether issuance would further management plan goals and objectives."

# What is the problem?

- Gopher Tortoises mortality rates might be rising due to land development when environmental surveys and land clearing permits are not enforced.
- It is a violation of Florida State Law when gopher tortoises are killed without the protections of an environmental survey and/or a land clearing permit; no matter what the size is of the land parcel.



## How can we fix this?

- 1. What can Indian River County do to support Florida State Law?
  - According to FWC Law Enforcement Officer C. Platt (with permission):
    *"Issue and enforce all land owner and land developers to do an environmental survey before the land is cleared and developed."*
- 2. Issue land clearing permits BEFORE <u>any</u> size land parcel is cleared or developed.
- 3. Develop and open more county land for gopher tortoise sanctuaries in accordance with the FWC-approved *Gopher Tortoise Management Plan* (2007).
  - Our Indian River County can be a successful model for other Florida counties to protect gopher tortoises!

## How can we fix this?


- 4. Provide the public information about their responsibilities to protect and SAFELY relocate Gopher Tortoises from their land (especially new land owners).
- 5. Coordinate public protection committees to work with Indian River County to help educate and inform our communities about gopher tortoises and their habitat.
